# 2009 SECOND SUNDAY ANTIQUE MARKETS

## Rules and Regulations

1. Only antiques and collectible items may be sold. ANTIQUE RUGS or CRAFT ITEMS must be approved by the promoter in advance. NO DVD's, CD's are allowed. T-shirts, jewelry, handbags, perfume, and other new items are at the discretion of the promoter. No firearms, knives, swords or weapons of any kind, alcoholic beverages, adult or illegal items of any kind may be sold.
2. Set up is from 8 am on. DO NOT UNLOAD OR SET UP BEFORE 8 AM! This is a residential area and disturbing our neighbors on a Sunday morning could cause the loss of Broadway Market Square. Parking is available on the street (Aliceanna St. is not metered) or in one of the lots at the west end of Thames St.
3. The Antique Market hours are from 8 am to 5 pm. No packing before 4 pm. You will find your best business hours between 1 pm and 5 pm. Please make every effort to be packed up by 6 pm. There is no selling after 6 pm.
4. Tables and chairs - You must bring your own
5. Cancellations - You must claim your space by 8:30 am or it will be re-rented. If you cannot make the Antique Market, please call and let me know so that I can try to re-rent your space.
6. No food of any kind shall be sold.
7. Each space is at least 17' x 12'. Dealers will be assigned space numbers by the promoter.
8. There are NO REFUNDS in case of inclement weather.
9. Unreserved or no-show spaces will be available at 8:30 am. at a cost of \$50.00 per space on a first-come-first-served basis.
10. **You must take your trash with you.** EACH DEALER IS RESPONSIBLE FOR REMOVING TRASH FROM HIS BOOTH AREA. Failure to clean up your booth area will result in being barred from future markets.
11. Spaces are NON-TRANSFERABLE. You may not transfer or sub-lease your space to someone else.
12. Restrooms are available at the Visitors' Center at 1724 Thames St, or the port-a-john located near the square.
13. If you do more than 3 Antique Markets you must have a Md. State Sales Tax number. It is the law that Sales Tax must be collected on all sales.
14. All decisions of the promoter or his/her representative are binding and final.
15. The dealer agrees not to hold the Preservation Society, or The City of Baltimore or its employees liable for any damage, injury or loss arising from this Antique Market.
